Dear Attorney General Maura Healey:

We write to inform you of an ongoing criminal conspiracy being committed by Jennifer Sattler-Murphy and Laurence Cournoyer, Jr., of the Holyoke Police Department.

I ask that you immediately arrest Timothy Symington for raping me as a child.

We ask that you investigate Detective Sergeant Mark Popielarczyk of the Easthampton Police Department for refusing to investigate the crimes of Jennifer Sattler-Murphy in this case and for refusing to accept evidence of her crimes in 2014.




3. Mark Popilearczyk told the parents of the victim, in front of Corey Robinson, that he couldn't give the Holyoke police report to the parents until after the investigation was over.

We ask that you investigate how it was possible for Timothy Symington to not have been arrested in 2014 given the overwhelming evidence presented and to investigate the role Corey Robinson played in helping to cover-up the crimes of Jennifer Sattler-Murphy by refusing to receive evidence pertinent to the investigation.

Dear Mayor Morse:

We write to inform you of what appears to be an ongoing criminal conspiracy on behalf of Jennifer Sattler-Murphy and Laurence Cournoyer, Jr., detectives in the Holyoke Police Department. It appears they were actively aided by Captain Denise Duguay, M.S. in keeping the evidence of their alleged wrongdoing hidden from us for as long as possible.

Given that the chief of police was copied on all of the correspondence in the case, like Captain Denise Duguay's infantile letter, it would appear that the chief of police is aware of the treatment a rape victim and their mother received from his department and found it acceptable. Consequently, we appeal to you hoping that, unlike the Holyoke police officers we have dealt with so far, you will not help a child rapist avoid prosecution.

It is our belief, based on the evidence, that Jennifer Sattler-Murphy and Laurence Cournoyer, Jr. assisted Timothy Symington in avoiding prosecution for the rape of a child and ask that you investigate. We also ask that you investigate the role Denise Duguay and the chief of police had in preventing us from obtaining a copy of the report.



Dear District Attorney Sullivan:

As a follow-up to our letter of April 2, 2017, we have just discovered that you were personally involved in this case in 2005 as Register of Probate for Justice Perlman.

Attached is a letter sent to you and your reply. **When reviewing your Judge's order barring an alleged pedophile from having any contact with his own son and ordering him into a year-long wife/child beating class, you informed the superintendent of schools: "There have been no court activities which lead me to believe there is any threat to the health or safety of any staff or students."**

Your legal opinion alone allowed a child rapist to continue teaching Longmeadow students in 2005. You successfully thwarted determined efforts to expose him and protect innocent children.

It is now obvious that you are not in a position to be impartial in investigating why Symington wasn't arrested in 2014. **Why you have not recused yourself from any aspect of this case, given your involvement in 2005, appears unethical at best.**

We are asking Attorney General Maura Healy to investigate your role in this case in 2005 and 2014 as well as that of Linda Pisano in 2014.

Unfortunately, the 2015 Longmeadow victims suffered unaware of your role in this case in 2005 and 2014. You, like a whole lot of other "adults" involved in this case, should be ashamed of your actions and their painful consequences for innocent children.

We urge you to resign your position immediately.

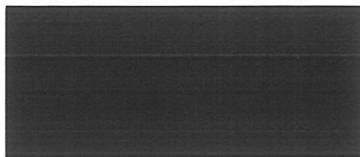

I write in response to your letter dated April 2, 2017, in which you question why criminal charges were not brought in connection with an investigation this office conducted in 2014. In response to your letter, I reviewed the investigative file pertaining to this matter (much of which you previously received in response to a public records request), and also discussed the investigation with the lead prosecutor on the case and the lead detectives on the case. They are unanimous in their conclusion that there was insufficient credible evidence to support the issuance of criminal charges, charges that the Commonwealth would have to prove beyond a reasonable doubt in order to sustain a criminal conviction. I concur in their conclusion.

As far as your other allegations and aspersions are concerned, they do not merit a response.
